## **FORWARD BALANCE STEP; ¼ TURN, POINT, HOLD**

- 1-3 Step L forward; Step R beside L; Step L back  
4-6 Make a ¼ turn right & step R to right; Point L to left (3:00), Hold

## **FULL ROLLING TURN LEFT; RIGHT TWINKLE STEP**

- 1 Make a ¼ turn left & step L forward (12:00)  
2 Make a ½ turn left & step R back (6:00)  
3 Make a ¼ turn left & step L to left (3:00)  
4-6 Step R across L, Step L to left, Step R beside L (3:00)

## **CROSS ROCK STEP; ¼ TURN, CROSS UNWIND ½ TURN, SWEEP**

- 1-3 Rock L across R, Recover back to R, Make a ¼ turn left & step L forward (12:00)  
4-6 Cross R around L, Unwind ½ turn left sweeping L from front to back (6:00)

## **BEHIND, SIDE, FORWARD; STEP LIFT, KICK**

- 1-3 Step L behind R, Step R to right, Step L forward to 4:30  
4-6 Step R forward; Lift L knee up, Kick L forward (4:30)

## **BACK, BACK, TOUCH, FORWARD, ½ TURN, STEP BACK**

- 1-3 Step L back, Step R back, Touch L in front of R  
4-6 Step L forward, Turn ½ turn left stepping R back (10:30), Step L back

## **½ TURN, SPIRAL TURN; FORWARD, ROCK STEP**

- 1-3 Make a ½ turn right & step R forward (4:30), Cross L over R, Unwind full turn R keeping weight on L (4:30)  
4-6 Step R forward, Rock L forward, Recover back to R

## **BACK, SWEEP; BEHIND, SIDE, CROSS**

- 1-3 Step L back, Sweep R for 2 counts from front to back  
4-6 Step R behind L, Step L to left, Step R across L

## **¼ TURN, STEP ½ PIVOT; FULL ROLL FORWARD**

- 1-3 Make a ¼ turn left & step L forward (12:00); Step R forward; Pivot ½ turn left to L (6:00)  
4-6 Turn ½ turn left stepping R back, Turn ½ turn left stepping L forward, Step R forward (6:00)

## **Begin Again**

**TAG: At the end of the 5th wall add tag,**

## **BALANCE FORWARD, BALANCE BACK**

- 1-3 Step L forward, Step R beside L, Step L beside R  
4-6 Step R back, Step L beside R, Step R beside L
