'I Want It That Way': 16 Counts, Start on Lyrics: 'You are'

#### SECTION 1: R LOCK STEP BRUSH; L ROCKING CHAIR; L STEP KICK; R COASTER

1&2& Step R forward, Lock L behind R, Step R forward, Brush L3&4& Rock L forward, Recover R, Rock L back, Recover R

5-6 Step forward on L, kick forward R

7&8 Step back on R, Step together L, Step R forward

### SECTION 2: L LOCK STEP BRUSH; R ROCKING CHAIR; R JAZZ BOX 1/4 W TOE-HEELS

1&2& Step L forward, Lock R behind L, Step L forward, Brush R3&4& Rock R forward, Recover L, Rock R back, Recover on L

5&6& Cross R (Toe touch & Heel drop) over L, Step back on L (L Toe touch & Heel drop)
7&8& Turn ¼ R (R Toe touch & Heel drop), Together L (L Toe touch and Heel drop)

#### SECTION 3: R & L SAILOR STEPS; 1/4 R, BACK ROCK RECOVER; MAMBO R

Sweep R behind L, Step L slightly to Left diagonal, Step R to Right diagonal Sweep L behind R, Step R slightly to Right diagonal, Step L to Left diagonal

5-6 Turn ¼ R, (Sweeping) Rock back on R, Recover L
7&8 Rock R to R side, Recover L, Step R beside L

#### SECTION 4: RIGHT HEEL JACK; ROCK RECOVER 1/4 R; SHUFFLE LRL

1-2& Step R to R side, Step L behind R, Step R to R,

3&4 Touch L heel diagonally Left, Step LF together w RF, Cross R over L

5-6 Rock side L, Turn ¼ R, Recover R,

7&8 Shuffle forward LRL
